#### **Regular Giving**

### **FINANCES EXPLAINED 2021**

# TRANSFORMED BY GRACE TO LOVE ONE ANOTHER, SERVE THE CITY, AND SHARE CHRIST

Our vision at St Mark's is to see our church and community transformed by God's grace through Jesus Christ. We invite you to partner with us.

As a church community, we are called to resource this vision.

This leaflet is designed to inform you about our finances and about how you can share in the ministry of St Mark's through your financial giving. We recognise these gifts are in addition to other ways people 'give' such as prayer, time and acts of service and love.

If you are not already giving regularly, we encourage you to join with us, so that together we can be as effective as possible in the work God has entrusted to us.

#### WHY SHOULD WE GIVE?

At St Mark's we recognise that everything we have belongs to God and has been entrusted to us as resources to be used for his purposes and glory.

- **1. God gives generously to us.** God is our generous father, and everything good we have comes from him. Most significantly, God gave himself for us: "God so loved the world that he gave his one and only Son" (John 3:16). We give because God gave first.
- **2. It's how we worship God.** According to the Bible, when we give generously, it is "a fragrant offering, an acceptable sacrifice, pleasing to God" (Philippians 4:18). We cannot worship both God and money.
- **3. To be spiritually enriched.** We do not give money hoping that God will give us more money in return. Rather, "It is more blessed to give than to receive" (Acts 20:35), because it cultivates a generous heart.
- **4. To enable ministry.** As Paul preached the gospel and raised up others to do ministry among the churches, he was supported by those churches (Philippians 4:15–16). By financially giving to gospel work, we can free up more people to multiply ministry and do God's work.



#### **HOW SHOULD WE GIVE?**

Giving should be regular (1 Corinthians 16:1–2) and proportional to our income. In the Old Testament, God's people were called to give a tenth of all they had. Now, we are called to sacrificial generosity, according to our ability (Luke 21:1–4). We are also called to give with a humble spirit Matthew (6:1–4).

#### WHERE DOES OUR MONEY COME FROM?

Funding for all our ministries comes primarily from our church community. We also have revenue from property rental and church activities. This is how we fund all our staff, resources, equipment, and repairs. Typical revenue comes from the following sources:



#### WHO IS IN CHARGE OF OUR FINANCES?

The church finances are the responsibility of the Wardens and the Treasurer (treasurer@stmarksdp.org). A monthly financial report is presented to Parish Council and audit-reviewed financial statements are presented to church members once a year. We seek to be transparent in our finances. Any church member can ask the Treasurer, or any Warden, or Parish Councillor any question with regard to St Mark's financial position.

#### WHAT DO WE SPEND OUR MONEY ON?

We spend our money in line with our vision, investing in God's kingdom both at St Mark's and elsewhere. In particular, we long to see the next generation won for Christ. Under God, we have grown in weekly attendance by 52% in seven years.

Ministry and parish administration salaries comprise about 60% of total expenditure. Our ministry staff serve the congregation and the wider community. They commend the good news, teach the Bible faithfully, and raise up and equip others to serve. They do this on Sundays and during the week and minister to youth and children, families, single people, and older people, and also serve those in need. They are supported by our administrative and music staff.

We also maintain St Mark's properties which includes the church building, our two halls, two properties for staff, and two other rental properties. The remainder of our income is spent on equipment, utilities, administration expenses, and resourcing our various ministries.
